Readiness testing is required for all applicants for admission to 1st through 12th Grade. Applicants for Kindergarten must have reached their fifth (5th) birthday by September 30th of the school year for which application is made. Applicants for First Grade must have successfully completed a Kindergarten program. A placement test and/or an informal placement evaluation with the grade level teacher(s) may be required for applicants in Kindergarten as a part of the admission process at the discretion of the Administrator and/or the Admissions Committee.
