The application review process includes an interview with the principal and requires receipt of the following: completed application form, fees and a copy of your child's most recent report card and birth certificate. Please allow 7-14 days for completion of the review process.

Readiness testing is required for all applicants for admission to First through Twelfth Grade. Applicants for our K4 program must have reached their fourth birthday by the first day of school. Applicants for Kindergarten must have reached their fifth birthday by **September 30** of the school year for which application is made. Applicants for First Grade must have successfully completed a Kindergarten program. A placement test and/or an informal placement evaluation with the grade level teacher(s) may be required for applicants in Kindergarten as a part of the admission process at the discretion of the Administrator and/or the Admissions Committee.
